



## Results based on Mini Pandemic Survey conducted between 06/03/2020 - 16/03/2020

1. About 70% respondents admitted that their customers had started asking questions about their Pandemic preparedness.



2. Over 80% respondents agreed that they had posted the similar questions to their vendors/suppliers.






3. A little over 30% responding organisations have provided masks to their employees. General principle is that a healthy person does not need to wear mask.



4. About 60% responding organisations admitted providing masks to their extended staff. This is a good practice specifically for the janitors.






5. Almost same number of organisations (most likely the same organisations) have provided gloves to their extended staff. Once again, this is a good practice for the janitors.




6. About 30% of the responding organisations still do not have a Pandemic Plan (either standalone or embedded in the BCM plan) ñ so there is still some work to be done in this direction.






7. Most organisations (about 65%) have not yet run a Simulation Exercise around Mass Absenteeism (the most likely impact of a Pandemic).




8. About 40% responding organisations have considered 25% - 50% mass absenteeism scenario in their planning. The same is 10% - 25% by about 20% responding organisations. It appeared that about 10% organisations have not considered this factor in their current BCM Planning.






9. About 25% responding organisations felt improvements were necessary in their awareness efforts for internal interested parties.



10. In the past, perhaps, there would be doubts about government(s efforts in dealing with a disaster, but in this survey, majority (over 90%) at least expressed their awareness about what the government or other authorities had been doing for the current Pandemic.
